UNIVERSITY REGULATION ON THE UNIVERSITY OF AIZU STUDENT SUPPORT COMMITTEE

(April 1, 2006 Regulation Number 15) (Most recent revision: May19, 2023)

Article One (Objective)

1.1 This regulation-based upon the provisions of Article 30 of the University Regulation Concerning The Internal Administrative Organization And Other Aspects Of The University Of Aizu - provides for the method of administration and other necessary matters of the Student Support Committee (for the purpose of this regulation, hereinafter referred to as "COMMITTEE").

Article Two

(Matters For Deliberation)

- 2.1 The COMMITTEE shall deliberate the following matters;
- (1) Matters concerning the extracurricular activities of students;
- (2) Matters concerning the commendation and discipline of students;
- (3) Matters concerning the health management, etc. of students;
- (4) Matters concerning the recommendation of and guidance of scholarship recipients; and
- (5) Other matters concerning the welfare guidance of students.

Article Three

(Organization)

- 3.1 The COMMITTEE shall be organized of the following individuals:
- (1) The Director General of the Department for Student Affairs; and
- (2) Members consisting of one individual selected from each of the academic divisions, the Center for Cultural Research and Studies, and the Center for Language Research.
- (3) Two members selected from the Graduate School.

Article Four

(Term Of Office)

4.1 The term of office of those members provided for under Paragraph 3.1, Item 2 above shall be two years; these members can be reappointed. However, the term of office of those members initially selected to fill a vacancy shall be the remainder of the vacated term.

Article Five (Committee Chairperson)

5.1 The position of Committee Chairperson shall be established within the COMMITTEE and shall be served by the Director General of the Department for Student Affairs.

Article Six

(Meetings)

- 6.1 The Committee Chairperson shall convoke meetings and serve as the chair thereof.
- 6.2 Should the Committee Chairperson be unable to fulfill his/her duties, the individual previously designated by the Committee Chairperson shall fulfill these duties on the Committee Chairperson's behalf.
- 6.3 The COMMITTEE, if for which more than half of the members belonging thereto are not present, may not be convened.
- 6.4 Matters before the COMMITTEE requiring a decision shall be decided by more than half of those members in attendance; and when there is an equal number of members supporting both sides of an issue, the chair of the committee meeting shall render the decision.

Article Seven

(Attendance By Related Individuals)

7.1 The Committee Chairperson, when he/she recognizes doing so as necessary, may require the attendance of related nonmembers for the purpose of requesting explanations from such nonmembers and having them provide opinions.

Article Eight

(Miscellaneous Affairs)

8.1 Miscellaneous affairs concerning the COMMITTEE shall be performed by the Student Affairs Division of the Administrative Office.

Article Nine

(Supplemental Provisions)

9.1 Other than provided for by this regulation, necessary matters concerning the administration of the COMMITTEE shall be determined separately by the Committee Chairperson by way of consultation with the COMMITTEE.

ADDITIONAL PROVISIONS

This regulation shall be enforced as of April 1, 2006.

This regulation shall be enforced as of May 20, 2009.

This regulation shall be enforced as of March 4, 2013.

This regulation shall be enforced as of April 1, 2019.

This regulation shall be enforced as of May 19, 2023.
