University Regulation on Conferring the Title of Professor Emeritus

Article One

(Objective)

1.1 This regulation provides for necessary matters regarding the conferment of the title of Professor Emeritus (hereinafter referred to as the "TITLE") of the University of Aizu under the authority of the School Education Law (Law No.26, 1947) Article 106.

Article Two

(Criteria For Selection)

2.1 Individuals with integrity who fulfill any of the followings shall be conferred with the TITLE through the selection process. However, individuals who have received salary reduction or more severe disciplinary punishments (excluding those for traffic accidents) pursuant to the provisions of Article 38 and 39 of the Office Regulations for Personnel of the Public University Corporation, The University of Aizu (April 1, 2006, Regulation No.36) during the period of employment shall be excluded.

(1) An individual who has served as a full professor (this excludes visiting professors) at the University of Aizu (hereinafter referred to as the "UNIVERSITY") for a period of 15 years or more and has made significant achievements in his/her educational and / or academic field

(2) An individual who has made significant contributions as the president or vice president of the UNIVERSITY

(3) An individual who has achieved outstanding results as a full professor at the UNIVERSITY in his/her educational and / or academic field

2.2 The number of years for which an individual has served at the UNIVERSITY provided for in the Article 2.1 above shall be calculated by month, and the periods described in the items below shall be considered as a period one served as a full professor at the UNIVERSITY. However, this shall exclusively apply to an individual who has served as a full professor at the UNIVERSITY for a period of 10 years or more.

(1) The entire period for which one has served as a full professor at the Junior

College Division of the UNIVERSITY

(2) Half of the period for which one has served as an associate professor (excluding visiting professors) at the UNIVERSITY or the Junior College Division of the UNIVERSITY, or as a full professor at other universities (including universities overseas)

(3) One third of the period for which one has served as a lecturer (excluding part-time professors) at the UNIVERSITY or the Junior College Division of the UNIVERSITY, as an associate professor at other universities, as a researcher at a public research organization, or as a researcher at a research organization from the private sector.

2.3 In the event there is an individual who fulfills the provisions of Paragraph 1, Item 3, the dean or director of the center or division to which said individual is affiliated shall submit said individual as a candidate for Professor Emeritus to the University President.

2.4 The submission of candidates in accordance with the previous paragraph shall be followed by deliberation by a commission of five deans and directors other than the dean or director that made the recommendation designated by the university president.

Article Three

(Selection Process)

3.1 The TITLE shall be conferred by the University President following a vote by the Deans and Directors Council.

3.2 The decision in the Article 3.1 above shall require the agreement of two thirds of the constituent members in attendance at the Faculty Assembly.

Article Four

(Conferment of the TITLE)

4.1 The TITLE shall be conferred to the faculty member concerned by written notification in the form attached when he/she retires from the UNIVERSITY.

Article Five

(Courtesy Services)

5.1 Professor Emeritus shall be accorded courtesy services such as reception of publication, invitation to important occasions, and access to the UNIVERSITY Library.

Article F Six

(Cancellation of the TITLE)

If individuals conferred with the TITLE took actions regarded defilement of the honor of the TITLE, the University President may cancel the TITLE following a vote by the Deans and Directors Council.
