

**Regulation for the Partial Revision of the Basic Regulation Concerning the Organization and Business Operation of the Public University Corporation, the University of Aizu**

(Regulation No. 82, February 26, 2007)

**Article One**

1.1 Part of the “Basic Regulation Concerning the Organization and Business Operation of the Public University Corporation, the University of Aizu (Regulation No. 12, 2006)” shall be revised as follows.

## **Article Two**

**2.1 Part of the “Ruling Concerning Implementation of the Regulation Concerning Accounting Policies (Ruling No. 2, 2006)” shall be revised as follows:**

**The term, “Policy Administrator of the Junior College Division,” in Article 5, Item 2, Article 18, Item 2, and Appendix 2 shall be changed to “Deputy Director General of the Junior College Division Business Office.”**

## **Article Three**

**3.1 Part of the “Ruling Concerning Management of Fixed Assets (Ruling No. 4, 2006) shall be revised as follows:**

**The term, “Policy Administrator,” in Article 6, Item 1 shall be changed to “Deputy Director General of the Junior College Division Business Office.”**

## **Article Four**

**4.1 Part of the “Regulation Concerning the University of Aizu Official Seal (Regulation No. 56, 2006) shall be revised as follows:**

**The terms, “University Division” and “Junior College Division” in Article 2 shall be deleted.**

## **Additional Provision**

**1. This regulation shall be enforced as of April 1, 2007.**
