# Regulation for the Partial Revision of the Basic Regulation Concerning the Organization and Business Operation of the Public University Corporation, the University of Aizu

(Regulation No. 82, February 26, 2007)

## **Article One**

1.1 Part of the "Basic Regulation Concerning the Organization and Business Operation of the Public University Corporation, the University of Aizu (Regulation No. 12, 2006)" shall be revised as follows.

#### Article Two

2.1 Part of the "Ruling Concerning Implementation of the Regulation Concerning Accounting Policies (Ruling No. 2, 2006)" shall be revised as follows:

#### **Article Four**

4.1 Part of the "Regulation Concerning the University of Aizu Official Seal (Regulation No. 56, 2006) shall be revised as follows:

The terms, "University Division" and "Junior College Division" in Article 2 shall be deleted.

### **Additional Provision**

1. This regulation shall be enforced as of April 1, 2007.
