Regulation on the Disclosure, Etc. of Official Documents Held by The Public University Corporation, The University of Aizu

(Regulation No. 2, August 1, 2012) (Regulation No.2, April 1, 2018) (Regulation No.33, April 1, 2023)

ARTICLE ONE (PURPOSE)

1.1 This Regulation stipulates the matters necessary for the enforcement of Fukushima Prefectural Information Disclosure Ordinance (Fukushima Prefectural Ordinance No. 5 of 2000; hereinafter, "ORDINANCE") with respect to the disclosure, etc. of official documents held by The Public University Corporation, the University of Aizu (hereinafter, "UNIVERSITY").

ARTICLE TWO

(OFFICIAL DOCUMENT DISCLOSURE WRITTEN REQUEST FORM)

2.1 The disclosure written request form in Paragraph 1 of Article 6 of the ORDINANCE shall be the Official Document Disclosure Written Request Form (Form No. 1).

ARTICLE THREE

(NOTICE OF OFFICIAL DOCUMENT DISCLOSURE DECISION, ETC.)

- 3.1 Notice pursuant to either the main clause of Paragraph 1 or Paragraph 2 of Article 11 of the ORDINANCE shall be given using the written notice form stipulated for the relevant type of decision in the following items:
 - 3.1.1 Decision to the effect of the disclosure of an official document in full pursuant to the main clause of Paragraph 1 of Article 11 of the ORDINANCE: Notice of Official Document Disclosure Decision (Form No. 2).
 - 3.1.2 Decision to the effect of the disclosure of an official document in part pursuant to the main clause of Paragraph 1 of Article 11 of the ORDINANCE: Notice of Official Document Partial Disclosure Decision (Form No. 3).
 - 3.1.3 Decision to the effect of non-disclosure of an official document in full pursuant to Paragraph 2 of Article 11 of the ORDINANCE (including a decision to the effect of non-disclosure when refusing a request for disclosure pursuant to Article 10 of the ORDINANCE or when the UNIVERSITY does not hold the particular official document pertaining to the disclosure request): Notice of Official Document Non-Disclosure Decision (Form No. 4).

ARTICLE FOUR

(NOTICE OF PERIOD EXTENSION FOR OFFICIAL DOCUMENT DISCLOSURE DECISION, ETC.)

4.1 Notice pursuant to Paragraph 2 of Article 12 of the ORDINANCE shall be given using a Notice of Period Extension for Official Document Disclosure Decision, Etc. (Form No. 5).

ARTICLE FIVE

(NOTICE OF APPLICATION OF EXCEPTION TO DUE DATE FOR OFFICIAL DOCUMENT DISCLOSURE DECISION, ETC.)

5.1 Notice pursuant to Article 13 of the ORDINANCE shall be given using a Notice of Application of Exception to Due Date for Official Document Disclosure Decision, Etc. (Form No. 6).

ARTICLE SIX

(NOTICE OF TRANSFER OF CASE)

6.1 Notice pursuant to Paragraph 1 of Article 14 of the ORDINANCE shall be given using a Notice of Transfer of Case (Form No. 7).

ARTICLE SEVEN

(GRANT TO THIRD PARTY OF OPPORTUNITY TO SUBMIT WRITTEN OPINION, ETC.)

- 7.1 The matters to be stipulated by the implementing agency under Paragraph 1 of Article 15 of the ORDINANCE shall be the following:
 - 7.1.1 The date of the disclosure request.
 - 7.1.2 A description of the information relating to that third party recorded in the official document pertaining to the disclosure request.
 - 7.1.3 The place where a written opinion is to be submitted, and the due date for submission.
- 7.2 Notice pursuant to Paragraph 1 of Article 15 of the ORDINANCE shall be given either using a Notice of Grant of Opportunity to Submit Written Opinion (Form No. 8), or orally.
- 7.3 Notice pursuant to Paragraph 2 of Article 15 of the ORDINANCE shall be given using a Notice of Grant of Opportunity to Submit Written Opinion.
- 7.4 Notice pursuant to Paragraph 3 of Article 15 of the ORDINANCE (including the event where applying mutatis mutandis pursuant to Article 21 of the ORDINANCE) shall be given using a Notice Pertaining to Disclosure of Official Document (Form No. 9).

ARTICLE EIGHT

(DISCLOSURE OF OFFICIAL DOCUMENT)

- 8.1 The disclosure of the official document (including a duplicate of the official document; the same shall apply to Paragraphs 2 and 3 of Article 8) pursuant to Paragraph 1 of Article 16 of the ORDINANCE shall be made on the date, at the time, and at the location that the Chairperson of the Board of Executives designates.
- 8.2 In the event that a person who inspects, listens to, or watches the official document tampers with, defaces, or damages the official document being inspected, listened to, or watched or is likely to commit such an act, the Chairperson of the Board of Executives may terminate or prohibit such inspection, listening to or watching of the official document.
- 8.3 One copy shall be delivered per official document.

ARTICLE NINE

(METHOD OF DISCLOSURE OF ELECTROMAGNETIC RECORDS)

- 9.1 The method to be stipulated by the Chairperson of the Board of Executives under Paragraph 2 of Article 16 of the ORDINANCE shall depend on the type of the electromagnetic records as stated in the following items, and shall be the method stipulated in that item for that type:
 - 9.1.1 Electromagnetic records that can be output onto paper: inspection of an object output onto paper or delivery of a copy thereof, or inspection, listening to, or watching of an object reproduced by means of specialized equipment (limited to specialized equipment provided for the purpose of inspecting, listening to, or watching objects subject to a disclosure decision; the

same shall apply hereinafter) or delivery of a duplicate thereof.

9.1.2 Electromagnetic records other than those described in 9.1.1: inspection, listening to, or watching of an object reproduced by means of specialized equipment, or delivery of a duplicate thereof.

ARTICLE TEN (LIABILITY FOR COSTS)

- 10.1 The amounts to be stipulated by the Chairperson of the Board of Executives under Paragraph 1 of Article 18 of the ORDINANCE shall be as stipulated in Appended Table 1.
- 10.2 The amounts to be stipulated by the Chairperson of the Board of Executives under Paragraph 2 of Article 18 of the ORDINANCE (including where applying mutatis mutandis pursuant to Paragraph 2 of Article 32 of the ORDINANCE) shall be as stipulated in Appended Table 2.
- 10.3 Costs prescribed in Article 18 of the ORDINANCE (including where applying mutatis mutandis pursuant to Paragraph 2 of Article 32 of the ORDINANCE) shall be payable in advance.

ARTICLE ELEVEN (NOTICE OF REVIEW BOARD CONSULTATION)

11.1 The notice pursuant to Article 20 of the ORDINANCE shall be given by a Notice of Review Board Consultation (Form No. 10).

ADDITIONAL PROVISIONS

These regulations shall co as of August 1, 2012.

ADDITIONAL PROVISIONS

These regulations shall be enforced as of April 1, 2018.

ADDITIONAL PROVISIONS

These regulations shall be enforced as of April 1, 2023.
